ABOUT WAYNE COUNTY CASA

Wayne County Court Appointed Special Advocates (CASA) is a nonprofit with a mission to ensure that children in the child welfare system who have experienced abuse and/or neglect are in safe and permanent homes.

WHAT WE DO

We recruit, screen, train, and supervise volunteer advocates to speak on behalf of children in foster care within the Third Judicial Circuit Court's Family Juvenile Division.

OUR GOAL

Our goal is to advocate for what is best for each child, and to see that every effort is made to reunify families when possible. When reunification is not possible, it is also the goal of Wayne County CASA to ensure that each child is placed in a home that offers stability, permanency, and a nurturing environment.

CASA IMPACT

How does our CASA model work?

- A CASA volunteer is a member of the community who becomes a sworn officer of the Court appointed by a jurist.
- We serve children from birth through 18.
- CASA volunteers are assigned to one case (one child or a sibling group)
- Because of the small number of children a volunteer serves at a time, they truly get to know the child and family and can give each case the sustained, personal attention it deserves.
- CASA volunteers work with legal and child welfare professionals, educators and service providers to ensure that jurists have all the information they need to make the most well-informed decisions for each child.
- Our best-interest advocacy is driven by the guiding principle that children grow and develop best with their family of origin, if that can be safely achieved. Most of the children we work with are in foster care but it is our hope they are able to return home whenever it is safe to do so.
