ABOUT WAYNE COUNTY CASA

Wayne County Court Appointed Special Advocates (CASA) is a nonprofit with a mission to ensure that children in the child welfare system who have experienced abuse and/or neglect are in safe and permanent homes. We recruit, screen, train, and supervise volunteer advocates to speak on behalf of children in foster care within the Third Judicial Circuit Court’s Family Juvenile Division.

Our goal is to advocate for what is best for each child, and to see that every effort is made to reunify families when possible. When reunification is not possible, it is also the goal of Wayne County CASA to ensure that each child is placed in a home that offers stability, permanency, and a nurturing environment.

In 2023, 47 CASA volunteers advocated for over 130 children. Help us double that number in 2024!
