#### ADVOCATING FOR THE FUTURE OF WAYNE COUNTY'S CHILDREN

Wayne County is Michigan's largest county by population, encompassing 43 communities, including Detroit. In 2023, over 35,000 investigations of child abuse and neglect were reported in the county, with over 6,300 confirmed cases and approximately 3,000 children placed in out-of-home care.\*

Wayne County CASA has served the Third Circuit Court—the largest circuit court in Michigan—for over 25 years. In 2022, we transitioned into a standalone 501(c)(3) nonprofit, strategically positioned to expand our impact for children who need us most.



## Meet Richard 'Tony' Braun: Wayne County CASA volunteer and winner of the 2024 Michigan CASA Volunteer of the Year award!

Tony Braun is an extraordinary person who embodies what it means to be an exceptional CASA volunteer. For the past five years, he has dedicated his time, energy, and heart to the Wayne County CASA mission, and he is currently working on his fifth consecutive case. Tony draws from his background as an attorney, a father, a husband, and long-time coach to serve children and families in our community. He fully understands his role as a CASA and advocates for each child's best interest, even when it's challenging.

Tony's commitment to CASA extends beyond Wayne County. He was the first volunteer in Michigan to serve as a Courtesy CASA, as part of a MICASA pilot program between Wayne County and CASA for Kids, Inc. His work as a Courtesy CASA set a precedent for future case collaborations across programs throughout the state. In his role as a Courtesy CASA, he was assigned to a



teenager placed in a residential facility in Wayne County. Tony met with that child regularly, providing emotional support during a time when that teen needed it most. At one point during the case, Tony advocated for transferring the youth's juvenile delinquency case to the same county as his child welfare case. The implications for this transfer changed the trajectory of the case, and this child's future. His CASA Advocate Supervisor, Ericka Brown, speaks highly of him stating, "Tony is supportive of both parents and children in the system, which is clear in his reports and recommendations. It continues to be an honor to serve as his supervisor over the years -our relationship is a partnership, as I have learned so much from him." It takes a CASA volunteer with exceptional insight and courage to speak up for children and youth as Tony does for all of his CASA children.




# **CHAMPIONS OF HOPE**
